Eligibility & Exclusion Criterion

The purpose of this policy is to establish clear criteria for the exclusion of individuals from residency in Celia Residential Assisted Living. The primary objective is to maintain a safe and secure living environment for all residents. Celia Residential Assisted Living may determine that an individual is not suitable for admission based on the following criteria:

Age Requirement

1. Prospective residents must be aged 50 and above to qualify for admission to Celia Residential Assisted Living.

Assessment and Evaluation

- 1. Each applicant will undergo a comprehensive assessment to determine their physical, emotional, and cognitive needs.
- 2. The assessment will be conducted by our professional staff to ensure that the level of care provided aligns with the individual's requirements.

Health Status

- 1. Prospective residents should be in generally good health or have stable health conditions that can be effectively managed within our residential assisted living environment.
- 2. Individuals with complex medical needs may be considered on a case-by-case basis, subject to the availability of appropriate resources and specialized care.

Behavioral Compatibility

- 1. Applicants should exhibit behavior that is compatible with communal living and adhere to home rules and guidelines.
- 2. Individuals with severe behavioral issues that may pose a risk to themselves, or others may not be eligible for admission.

Legal Capacity

1. Prospective residents must have the legal capacity to enter into a residential assisted living agreement or have a legal representative authorized to act on their behalf.

Financial Responsibility

1. Residents or their responsible parties must be able to meet the financial obligations associated with residing at Celia Residential Assisted Living.

Exclusions Criteria:

Convicted Sex Offenders

1. Individuals who have been convicted of any sex-related offense will be ineligible for residency.

Those Convicted of Violent Crimes:

1. Individuals who have been convicted of any violent crime, including but not limited to assault, battery, robbery, homicide, or any offense causing significant physical harm to others, will be excluded.

Background Checks

1. All prospective residents will be required to undergo a comprehensive background check as part of the admission process. This check will include but is not limited to, criminal history, sex offender registry, and any relevant public records. Prospective residents will be informed of the exclusion criteria during the initial inquiry and application process. Any individual found to meet the exclusion criteria will be denied residency. In the event that an individual's background check reveals a criminal history, the case will be reviewed by Celia Residential Assisted Living administration to ensure accuracy and fairness. However, individuals with convictions for sex offenses or violent crimes will generally be excluded. All information obtained during the background check process will be handled with utmost confidentiality and in compliance with applicable laws and regulations.

Severe Medical Conditions

1. Individuals with medical conditions that require specialized care beyond the scope of our capabilities may be excluded.

Unmanageable Behavioral Issues

1. Those with severe behavioral issues that may jeopardize the safety and well-being of themselves, or other residents may not be admitted.

Legal Incapacity

1. Individuals lacking the legal capacity to enter into a residential assisted living agreement and without an authorized legal representative may be excluded.

Financial Inability

1. Individuals unable to meet the financial obligations associated with Celia Residential Assisted Living may not be eligible for admission.

Inability to Manage the Condition

1. If an individual's infectious disease requires medical interventions or isolation measures beyond what the facility can reasonably provide, exclusion may be considered.

Non-Disclosure or Misrepresentation

1. Failure to disclose or intentionally misrepresent information about an infectious condition during the application process may result in exclusion.

Non-Compliance with Infection Control Measures

1. Residents who consistently fail to adhere to infection control measures and precautions recommended by healthcare professionals may face exclusion.

Review and Appeals Process

1. Residents who are deemed ineligible due to infectious diseases will be informed of the decision in writing. A clear process for appeals will be provided, allowing individuals to present additional information or seek reconsideration.
